**RESERVATION:**

A signed contract and non-refundable deposit of 20% of the total package is required to reserve the specified date. In the event of a cancellation, if the date can be rebooked by another client, deposit will be refunded.

**PAYMENT SCHEDULE:** A deposit is required at the time of reservation. A payment of 60% of the total package must be paid on or before the date of the wedding rehearsal. The remaining 20% plus payment for any additional DVD copies and extra hours are due before products are delivered. Cash, Credit Cards and Personal Checks are accepted.

**COOPERATION:**

The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. TYG Weddings hereby agrees to complete the video assignment to the best ability. Some limitation may apply if necessary footage is not available or provided. In the unlikely event that TYG Weddings equipment is damaged by the CLIENT or a guest of the CLIENT, the CLIENT assumes financial responsibility for the damages of the item(s).

**HOUSE RULES:** The videographer is limited by the guidelines of the location site management. It is the CLIENT's responsibility to secure access to areas for videography. TYG Weddings will not be responsible for coverage lost due to access restrictions.

**EXHIBITION:** The CLIENT grants TYG Weddings permission to display any video resulting from this assignment as an example of TYG Weddings work on websites and other sample viewings.

**LIMIT OF LIABILITY:** In the unlikely event that the videographer is injured or becomes too ill to film the event, responsibility and liability is limited to the return of all payments received for the event package.
